Background

This document is to explain the changes which have occurred with the introduction of New Commerce Experience (NCE) and how this affects API users.

PRISM Glossary of Terms

Before delving into detail on the PRISM APIs you will need to understand some terms used in the PRISM platform to understand the design of the PRISM API's.

Legacy Subscription

A subscription which is associated with a product sold under the original sales motion operated by Microsoft. These products have a SKU in a GUID format e.g.: "61795CAB-2ABD-43F6-88E9-C9ADAE5746E0" for "Microsoft 365 Business Premium"

NCE Subscription

A subscription which is associated with a product sold under the new sales motion operated by Microsoft. These products have a SKU in a format separated by a colon e.g.: "CFQ7TTC0LCHC:0002" for "Microsoft 365 Business Premium (NCE Product)". The name of NCE products will contain "(NCE Product)" to better highlight they are related to NCE, but this may change over time.

Backwards compatible: Yes

Orders for Monthly Billing Cycle will be interpreted as Monthly Term.

Orders for Annual Billing Cycle will be interpreted as Annual Term.

Customers must update their integrations if they require the ability to specify different combinations of billing cycle and term.

Change Quantity

Rules of NCE will mean quantity change down will fail when performed outside of 3-day cancellation window. See "CancellationAllowedUntilDate".

Change Status

Suspend

Backwards compatible: Yes

Rules of NCE will mean NCE subscriptions on suspended status are still billed. Subscription will update to 'Deleted' status when the renewal date occurs. To stop charges see Cancel Subscription.

Resume

Cancel

Backwards compatible: New API

Stops a subscription from being billed. Can only be performed during the 3-day cancellation window. See “CancellationAllowedUntilDate”.

Renew – Annual Billing

Backwards compatible: Yes

For annual billing, annual term subscriptions, rhipe requires that users confirm renewal within 3 months of the subscription’s renewal date. This is unchanged under NCE.

Renew – Monthly Billing

New API Under Development. ETA April 2022.

For monthly term subscriptions, users will want to toggle if a subscription should renew or not. By default, all subscriptions are set to auto renew every month. The ability to turn off auto renew is required so that users can specify mid-month that the licenses are no longer required because NCE does not allow user to suspend a subscription mid-term anymore.

It is recommended that a support ticket be raised to partner.support@rhipe.com if user would like to toggle auto-renew off for a subscription mid-term.

Price Lists

Backwards compatible: Yes

Under NCE, pricing will now be different when you purchase as Monthly or Annual Term. Under legacy, the annual price was 12 * monthly price. Under NCE the annual price has no relationship to monthly pricing.

Most API end points relating to pricing will now have an additional parameter to specify the billing cycle. This will provide the different pricing for each purchasing choice. When selecting Annual pricing, the API will return the price for the full year. If Tri-annual pricing is required, user must multiply the TermDurationNumber by the annual price. See “TermDurationNumber” under Data in this guide.

If no billing cycle option is provided in the API request, the API will default to Monthly pricing.

Helpful New Data

Subscription Model

CancellationAllowedUntilDate

Displays the UTC datetime that the 3-day cancellation window will close.

IsMicrosoftNewCommerceExperience

Displays if a subscription is associated to a product sold under NCE.

CommitmentEndDate

Unchanged but MS logic will see this updated to reflect the new Monthly term option. Monthly term subscriptions will see this value update every month.

TermDurationNumber

TBA. Specifies the number portion of a Term Duration. For example, a 3-year term denoted by Microsoft as P3Y would store the value "3" in this property.

TermDurationUnit

TBA. Specifies the unit portion of a Term Duration. For example, a 3-year term denoted by Microsoft as P3Y would store the value "YEARS" in this property. The value would still be set to 'YEARS' if the value was 1-year.

ProductSku

NCE products have a SKU in a format separated by a colon e.g.: "CFQ7TTC0LCHC:0002" for "Microsoft 365 Business Premium (NCE Product)". The name of NCE products will contain "(NCE Product)" to better highlight they are related to NCE, but this may change over time. Our recommendation is to refer to the format of the product SKU to identify if it belongs to NCE or not.

IsMicrosoftNewCommerceExperience

TBA. A Boolean to more easily identify a product belongs to NCE.
